## **INTRODUCING NEW MEMBER, ELEANOR THOMAS**

Born in Philadelphia, PA, Eleanor became a registered nurse and practiced for 50 years, married, had four children---two sons and two daughters---and resided in South Jersey during family-rearing years. She relocated to Montrose in 2007 to be near one of her daughters and her family but has spent the last year in the east due to a family matter, just recently returning. Eleanor joined the League because of her interest in politics and social issues which were fostered by a high school civics teacher. She explained that although it was stressful at the time because her parents didn't subscribe to a newspaper, she carried through on her assignments to bring an article to class each day and be prepared to discuss it, and got hooked.

## **INTRODUCING NEW MEMBER, TANYA ISHIKAWA**



Born in Dover, Delaware, Tanya's family moved to Aspen, Colorado in 1974 when she was 8. She received her bachelor's degree in Journalism and Public Relations from the University of Colorado-Boulder and subsequently moved to Tokyo, Japan in 1989, where she lived and worked in public relations for five years. Tanya moved back to the U.S. in 1994 and came to live with her parents who had relocated to Colona---quite a change from Tokyo! Industrious woman that she is, she established a tour company specializing in taking Japanese tourists to Native American reservations throughout the west before moving to the Front Range in 1998. There she worked in journalism, first at a newspaper and then as a freelance writer and public relations professional, and in 2000, she married Yasuo Ishikawa who was employed at the Japanese Consulate in Denver and whose interests extended from sushi to saxophones! At this time, Tanya began to run for political office as a Green Party candidate and garnered 10,000 votes when she ran for Jefferson County Commissioner. Despite failing to win other elections, she persevered, first being appointed to a seat on the Federal Heights City Council to serve two years, and then receiving more than 60 percent of the votes in 2011 to return to her council seat. She also served on the board of the Open Media Foundation, which operates the Denver public access television station. However, due to her mother's death and her father's illness, she cut her service short to move back to Colona in the fall of 2014 with her husband and then 9-year old son, Canyon. Tanya now works as a writer, editor, videographer, and website content manager for newspapers, magazines, nonprofits and small businesses, in addition to serving as communications coordinator for the Friends of Ridgway Schools, a volunteer parent group. Our newest member joined the League because she feels that being an informed voter is the best---only---way to have an effective government that represents the people.

## **INTRODUCING NEW MEMBER, DIXIE RINEHART**



Dixie Rinehart was born and raised in Michigan, served in the Air Force in California, and started his family in Dover, Delaware. There, he was a member of the team responsible for the spacesuit worn by the astronauts in the first missions to the moon, including Neil Armstrong's Apollo 11 Moon Landing in 1969. In 1974, he, his wife Carol and three children moved to Aspen, Colorado, where he worked as a design engineer on a wide range of products from ski gloves and ski boot warmers to pinball machines. In 1993, with all three children out of the house, they moved to the wide open spaces of Colona. Do the locales sound strangely familiar? Mr. Rinehart is the father of Tanya Ishikawa!

### **Stopping Partisan Gerrymandering and Protecting Independent Redistricting Commissions**

Yesterday, the U.S. Supreme Court issued a big victory for citizen-led democracy. In a 5-4 decision in *Arizona State Legislature v. Arizona Independent Redistricting Commission*, the Court found that voters can set up independent redistricting commissions. The state legislature in Arizona had challenged the constitutionality of the state's independent redistricting commission created by popular vote through a ballot initiative.

An *amicus* [brief by the League](#) and other concerned organizations pointed out that the Court had already ruled that excessive partisan gerrymandering is unconstitutional and argued that the "people" of the state should be able to protect themselves and their state from this unconstitutional practice. The Leagues of Women Voters of [Arizona](#) (PDF) and [Illinois](#) (PDF) also joined amicus briefs in support of independent commissions. The [League of Women Voters of Arizona](#) supported the original ballot initiative that led to the independent commission and helped lead the fight against the legislature's challenge.

In the majority opinion, [Justice Ruth Bader Ginsburg](#) invoked the [Federalist Papers](#) and a key tenet of our representative democracy: that voters select their representatives and not the other way around. Recognizing the problem of partisan gerrymandering, Arizona voters removed the redistricting process from their state legislature and instead created a bipartisan and independent commission to draw fair districts. Following the decision, [League president Elisabeth MacNamara](#) issued a [statement](#):

This is a tremendous victory for democracy. Drawing the boundaries of legislative districts is too important to leave to politicians... Today, the highest court in the nation strengthened the power of the people to protect themselves from excessive partisan influence and incumbency protection in redistricting. This is a great for democracy and for those that believe in fair, effective representation for all.

The impact of this decision reaches far beyond Arizona. [Over a dozen other states](#), including [California](#), have used a similar independent redistricting process to prevent partisan gerrymandering.

### **50th Anniversary of The Voting Rights Act of 1965**

Signed into law by [President Lyndon B. Johnson](#) during the height of the [American Civil Rights Movement](#) on **August 6, 1965**, this landmark piece of federal legislation prohibits racial discrimination in [voting](#). According to the [U.S. Department of Justice](#), the Act is considered to be the most effective piece of [civil rights](#) legislation ever enacted in the country.

In [Shelby County v. Holder](#) (2013), the [U.S. Supreme Court](#) struck down the coverage formula as unconstitutional, reasoning that it was no longer responsive to current conditions.

Current proposed legislation, the Voting Rights Advancement Act (VRAA), if passed by Congress, will restore that key protection of the landmark voting rights legislation by updating the formula that determines which states have to get federal permission—or preclearance—before making any changes affecting voting or elections. The new formula targets all or parts of thirteen states with a pattern of disenfranchising minority voters. **Voter discrimination cannot be tolerated.** [Tell your members of Congress to restore its key protections!](#)
